WHEREAS, the said Declaration was amended and supplemented by the following instruments recorded in the Official Records in the Office of the County Recorder of the County of Los Angeles:

- (1) First Amendment to Declaration of Restrictive Covenants, Conditions and Restrictions recorded on July 20, 1964 as Instrument No. 5335;
- (2) Supplementary Exhibit "B" to Declaration of Restrictive Covenants, Conditions and Restrictions recorded on November 16, 1964 in Book M1675, Pages 793 through 798 inclusive;
- (3) Amendment to Supplementary Exhibit "B" and to Declaration of Restrictive Covenants, Conditions and Restrictions recorded on July 30, 1965 in Book M1934, Page 519;
- (4) Second Supplement to Exhibit "B" recorded August 10, 1966 in Book M2312, Page 399;

WHEREAS, said Declaration of Restrictive Covenants, Conditions and Restrictions, as amended and supplemented, is applicable to the following described real property in the

Lots 1 through 103 of Tract 27460 as per map recorded in Book 696, pages 27 to 32, inclusive of Official Records in the Office of the County Recorder in Los Angeles County.

Lots 1 through 60, inclusive, of Tract 29326, as per map recorded in Book 731, pages 15, 16 and 17, inclusive, of Official Records in the Office of the County Recorder of Los Angeles County.

Lots 1 through 33, inclusive, of Tract 24455 as per map recorded in Book 754, pages 68 through 70, inclusive, in the Official Records of the County Recorder of Los Angeles County; and

WHEREAS, Section 8 of the said original Declaration of Restrictive Covenants, Conditions and Restrictions provides for an Architectural Committee composed of Harlan J. Lee, Stuart Jaffe, and Leon D. Widegren; and

WHEREAS, Section 7 of the said Declaration of Restrictive Covenants, Conditions and Restrictions, as amended and supplemented, provides for the formation of a property owners association and further provides that such association, after its formation, shall perform the functions of the Architectural Committee established under Section 8; and

WHEREAS, such property owners Association was formed on August 16, 1963, being Los Feliz Estates Owners Association,

a California corporation, which corporation has at all times since its formation exclusively performed the functions of the Architectural Committee established under Section 8; and

WHEREAS, there is a document of record on July 17, 1967, at Book M2605, Pages 450 and 451, which purports to reconstitute the Architectural Committee in the names of Joseph Bruna, Harlan Lee, and Wesley Lester, which is in conflict with the regular appointed and acting members of such committee installed by the Board of Directors of the Los Feliz Estates Owners Association; and

WHEREAS, the Los Feliz Estates Owners Association has claimed that said purported committee composed of Joseph Bruna, Harlan Lee, and Wesley Lester has not been appointed by the Association, is spurious, and without power; and

WHEREAS, the undersigned Joseph Bruna, Harlan Lee, and Wesley Lester, to clarify and remove any ambiguity from the record, desire to relinquish and transfer of record all powers, duties, functions and authority which they may have as the purported successors to the original Architectural Committee established under Section 8 of the said Declaration of Restrictive Covenants, Conditions and Restrictions, as amended and supplemented, to the said property owners association; and

WHEREAS, said property owners association is willing to accept such relinquishment and transfer and to undertake to perform all of the powers, duties, functions and authority of the Architectural Committee established under Section 8;

NOW, THEREFORE, the undersigned Joseph Bruna, Harlan Lee, and Wesley Lester hereby irrevocably relinquish, and transfer to Los Feliz Estates Owners Association, a California

corporation, whose address is 2216 Winona Boulevard ,
Los Angeles, California 90027, its successors and assigns, all
powers, duties, functions and authority which they may have as
the Architectural Committee established under Section 8 of the
Declaration of Restrictive Covenants, Conditions and Restrictions
as amended and supplemented.

Los Feliz Estates Owners Association by its execution hereof accepts the foregoing relinquishment and transfer and agrees to perform all powers, duties, functions and authority of the Architectural Committee established under Section 8 of the Declaration of Restrictive Covenants, Conditions and Restrictions, as amended and supplemented, in accordance with the provisions of its Articles of Incorporation and its By-Laws.

Los Feliz Estates Owners Association, by its execution hereof, recognizes and agrees that the location and height of the buildings, structures and improvements constructed, under construction, or to be constructed in Tracts 27460, 29326 and 24455 by, or on behalf of, Los Feliz Estates, Inc., Trans-World Financial Co. (successor in interest to Los Feliz Estates, Inc.), or TWF Investments, Inc. (a wholly owned subsidiary of Trans-World Financial Co.), or any subsidiary corporation of the foregoing, shall be conclusively deemed to not violate the provisions of paragraph 3(b) of the said Declaration of Restrictive Covenants, Conditions and Restrictions, as amended and supplemented, and that plans and specifications for buildings, structures and improvements constructed, under construction, or to be constructed by any of the above named corporations or their subsidiaries need not be submitted to or approved by Los Feliz Estates Owners Association or by an Architectural Committee designated by i.t.


