SECURITY REPORT Kevin Tent, LFEOA Security Chair

Dear Homeowners,

It's that time of year where we see an uptick in suspicious activity, vagrancy, package theft and occasional break-ins of cars and homes. This is an ongoing issue that the Board along with Post Alarm take seriously. To enhance our community's security, the Board has recently decided to partake in a pilot program to upgrade our license plate reading cameras on the corners of Hobart and Winona.

With a software upgrade our current "Flock" cameras will send push notifications to Post Patrol (in the evening hours) if a car entering is **not** registered on our SAFE LIST. For this security measure to work we encourage all residents to register their cars as soon as possible. You will be receiving a request to register and/or re-register from Post Alarm in the near future.

We are also exploring adding additional Flock Cameras at our entrances which have enhanced picture quality and a 180-degree view. Security technology is rapidly changing and the board is diligent in staying up to date with the latest advancements to keep our neighborhood safe.

Till then remember to lock your cars and always set your home alarms even if you're leaving for a short period of time.

On a positive note, a look at the local crime map shows that Los Feliz Estates and the surrounding area are well ahead of the curve when it comes to safety. You can view this map at: https://www.crimemapping.com/map/ca/losangeles

Finally, a reminder for everyone to watch their speed while driving through our neighborhood. Speeding, often by our own residents, remains a serious concern for us all.

Volunteering to serve on a Board may often be viewed as a thankless chore, but it has been a rewarding experience for me to

contribute to the growth and well-being of our neighborhood.

I want to extend my heartfelt thanks to my fellow board members and our manager, Glenn Purdy, for their unwavering collaboration over the years. The year 2024 brought a relatively quiet year on the legal side with the exception of one homeowner who continued to engage in conduct that violated the Covenant, Conditions & Restrictions that required involvement from our legal team. The Board anticipates that the legal issues involving this habitual offender is near completion and will work diligently to ensure that the most financially prudent, yet legally consequential, measure is taken to put finality on this legal issue. To that extent, the Board does anticipate some increase in legal fees for 2025 as we work to enforce the CC&R to continue maintaining this community a peaceful and enjoyable place for all.

When doing your architectural project, please remember as a policy the board does not allow contractor signs advertising their services to be posted on the property. Please make sure to keep the sidewalk unobstructed where possible. It will also go a long way in good neighbor relations if you or your contractor walks around the property at the end of each day to make sure all trash and debris is cleaned up, which includes the sidewalk and gutter.

And don't forget to inform all contractors about the possibility of theft of their tools. Be alert, keep everything secured and locked at all times. It only takes a minute to lose valuable equipment.

Did you know that the streets and sidewalks are not part of the Association's maintenance responsibility areas? The Los Feliz Estates Owner's Association is fiscally solvent and there are no past due

assessments. Our 2024 budget was built upon homeowner's dues and a carryover from the 2023 year. Our reserve account is fully funded for 2024. Security and landscaping (gardeners, brush clearance, irrigation repairs and tree trimming) are our largest budget items.

The 2025 assessment will increase by \$705 from \$3,525 to \$4,230. Please find included with this Annual Policy Statement packet the notice of increase and explanation from the board.
